Crowdfunding

The phenomenon and evolution of Security Token Offerings (STOs) sprung up from the success of Indiegogo, Kickstarter and then Initial Coin Offerings (ICOs) — an unregulated form of crowdfunding mirrored after Initial Public Offerings (IPOs).

Individuals and teams raised significant funds with just great ideas, vision and purpose, and it was easy to get started... *easy to get in the race.*

By 2017 we saw massive amounts of capital was raised: USD 4.2 billion by EOS (Block.one) as an example. In 2017 a total of USD 4-5 billion was raised through ICOs ... USD 12 billion was raised in 2018 and USD 7 billion in 2019.



Fraud, Money Laundering Dark Pools Formed

Let's face it, retail and even professional investors didn't always perform thorough due diligence, KYC and AML checks.

ICOs became a haven for fraud.

The Wall Street Journal reported that upwards of 20% of ICOs were fraudulent in 2017 in a research study conducted.

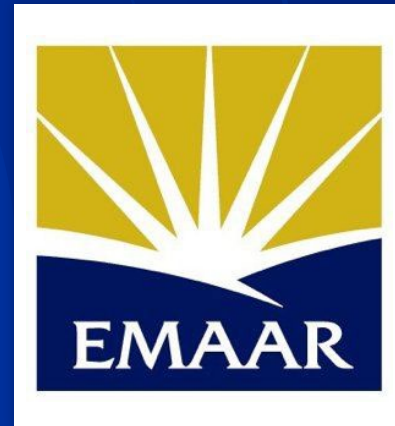
